

2024 LINCOLN CORPORATE GAMES

The 2024 Lincoln Corporate Games brought together employees from 50 companies to compete in 13 virtual and in-person events from August through October in Lincoln. The Corporate Games aim to promote employee wellness, team-building, and company pride.

Awards included gold, silver, and bronze medals for the top three teams in each event, as well as overall company plaques based on a point system that rewards participation and event performance.

The 2024 events included Bowling, Canned Food Drive, Cornhole, Electronic Darts, Golf Scramble, Miniature Golf, Pickleball, Sand Volleyball, Table Tennis, Trail Walk, Trivia Challenge, Virtual 5K, and Virtual Cycling.
